Michael Gonidakis, Executive Director of Ohio Right to Life, will be the keynote speaker. Before joining ORTL, Gonidakis practiced law in Columbus and served as campaign manager for pro-life Ohio Supreme Court justices Terrence O'Donnell and Robert Cupp.

Also joining us will be ORTL Director of External Affairs, Gillian Stechschulte. Stechschulte is a recent graduate of Miami University, where she studied architecture and design and was involved in Campus Crusade for Christ.

Special local guests include Michelle Dieperink, Connie McEldowney, and Elizabeth Trisler. Dieperink, a nurse residing in Troy, will share her personal abortion story. McEldowney, a Russia member of RTL, will talk about her pro-life children's book, Josiah's Journey. Trisler will speak about her experience as the winner of National Right to Life's oratory contest.

## Trisler Receives Ohio House Commendation, Finally



Elizabeth Trisler, winner of Shelby County, Ohio, and National Right to Life Oratory Contests, received her much-deserved and much-delayed proclamation from the floor of the Ohio House on February 17. The proclamation was presented to the Shelby County teen for her hard work, determination and outstanding national achievement at the Right to Life Oratory Contest. She also received similar recognition from the Ohio Senate, a measure introduced by Senator Keith Faber.

Trisler had received national publicity when House Speaker Armond Budish accepted, postponed, and then cancelled a request by Trisler's State Representative, John Adams, to present the proclamation on the House floor. After receiving extensive criticism from Ohio Right to Life, a wide variety of other groups, and national, state, and local media, Speaker Budish relented and allowed the presentation.

The controversy received attention from FoxNews, where Elizabeth and her mother Sandi appeared, many Ohio papers, including the Cleveland Plain Dealer and Columbus Dispatch, and national pro-life news outlets.

"We are pleased that this talented and committed young woman received the honor she deserved," said Elyse Putnam, Public Relations Director for Ohio Right to Life. "We are also pleased that the correct message has finally been sent to Ohio teens that respectful participation in the debate over the great issues of our time is something our democracy should encourage, not stifle," said Putnam.

## **\$38 Trillion: Abortion's Economic Impact**

In its latest estimate on the economic impact of abortion, the Movement for a Better America is reporting that the abortion toll is projected to climb to a new high of 52,333,000 as of January 22, 2010, the 37th anniversary of Roe v. Wade. The group also estimated that the economic impact has risen to \$38.5 trillion in lost U.S. Gross Domestic Product (GDP) since 1970.

"This year alone, the impact involved another \$2.45 trillion, or roughly equal to half the GDP of Germany and France combined," said the Movement in a press release.

MBA President Dennis Howard, who has been researching the economic impact of abortion since 1992, said, "The number of lives lost to surgical abortion has reached 17% of the total U.S. population of 307,000,000. So it's not surprising that this year's increase is equal to 17% of U.S. GDP."

The estimates are based on average GDP per year since 1970 after abortion became legal in our largest states and the cumulative number of abortions. The estimates do not include babies lost to abortifacients and contraception because of the lack of public data.

Howard has been warning since the mid-1990s that the US faced a major financial crisis based on ongoing demographic trends. He cited the collapse of the former Soviet Union as an example of the impact of demographics on economies.

"The main reason for their collapse was internal – 300 abortions for every 100 live births for decades ... Right now, there are not enough younger women to reverse their population decline. They could lose another 40 million people by 2050."
