## Election 2012: Values to Votes

Jan. 22, 2013 will be the 40th anniversary of Roe v. Wade. The challenge of Election Day, Nov. 6, 2012 is to translate pro-life values into votes so that this can be the last commemoration of that anniversary. Whoever is elected president may have the opportunity to nominate two or more Supreme Court justices. Congress will have the opportunity to repeal Obamacare and cut off funding for Planned Parenthood. What can each of us do to insure a pro-life victory?

## A Pro-Life Perspective on the Todd Akin Controversy Should There Be a Rape Exception in Abortion Laws?

Rebecca Kiessling, a pro-life attorney from Michigan, fully understands the national debate going on concerning the controversial comments Missouri Senate candidate Todd Akin made about abortion and rape. Kiessling was conceived when her mother was victimized by a rapist.

While abortion advocates often talk about supporting a woman's right to privacy, Kiessling says rape exceptions in abortion laws turn that notion on its head. "Rape exceptions in the law actually put the government in the position of having to ascertain when the child was conceived, who the father is, whether the child was conceived during the alleged rape or during intercourse with her husband or boyfriend, and if the child was conceived during the time frame of the alleged rape, then the government would need to determine whether the sexual intercourse was consensual or not," she explained. "So rape exceptions serve to perpetuate the injustice against rape victims that their accounts are to be viewed with skepticism, and it further leaves the majority of impregnated rape victims wholly unprotected under the law. Rape exceptions suggest that a "real rape victim" couldn't possibly love "the rapist's baby" and that rape victim mothers don't exist."

Kiessling gives a three-step process in terms of how candidates should answer the question:

1. The Supreme Court has said that the death penalty is cruel and unusual punishment for rapists and that rapists don't deserve the death penalty. I don't think the innocent child conceived in rape deserves the death penalty for the crimes of her father. It seems to me that is cruel and unusual punishment.
2. Rape victims are four times more likely to die within the next year after the abortion, with a higher rate of suicide, murder, drug overdose, etc. As someone who really cares about rape victims, I want to protect them from the rapist, and from the abortion, and not the baby. A baby is not the worst thing that could ever happen to a rape victim — an abortion is.
3. Rape victims choose abortion at half the rate of the average unplanned pregnancy, which is over 50%. Only 15-25% of rape victims choose abortion, depending on the study. The majority of rape victims choose to raise her child — not "the rapist's baby" — HER child.

Of course, I also think it helps to share a personal story and there are lots available, of women who became pregnant by rape and either regret aborting, are raising their children or are birth-moms, as well as stories of those of us conceived in rape and/or incest. Right to Life of Shelby County does not endorse candidates. It is our mission to educate and inform members about candidate positions. To that end, we offer the following reflection:

How important is it to consider a candidate's devotion to protecting human life, above all other factors? In the context of American history, that question is well answered by considering this question: Do you know anyone who would vote for a candidate who would promote slavery? Even if he claimed to be "personally against slavery"? Even if she seemed to have good economic policies? No one would support such a candidate today. It should also be the case that no one would support a candidate who accepts laws that permit or fund the killing of pre-born children and disabled or aged adults. Abortion, euthanasia, assisted suicide, embryonic stem cell research, and human cloning entail the intentional killing of innocent human beings at particular stages of life. Anyone who considers these practices wrong has an obligation to evaluate the following critical questions.

First and foremost, is the candidate truly dedicated to protecting all human beings from the moment of conception onward? If no, then it would be detrimental to the defense of innocent life to vote for this candidate and to do so would be cooperating in his pro-death efforts. This candidate may be supported only if there is no alternative pro-life candidate, and he is judged to be the one who would be least harmful to the cause of life.

If yes, the candidate is pro-life, then he may be supported. If both (or all) candidates are pro-life, the following questions may be helpful in distinguishing among them: Has the candidate ever publicly supported another candidate who does not support protection for human life? Does the platform of his political party reflect a pro-death or a pro-life point of view? A pro-life candidate can come from any party. Party platforms, however, state specific positions regarding protection of human life.

The most recent Democratic Party platform reads: "The Democratic Party strongly and unequivocally supports Roe v. Wade and a woman's right to choose a safe and legal abortion, regardless of ability to pay, and we oppose any and all efforts to weaken or undermine that right."

The most recent Republican Party platform has a long section entitled Maintaining The Sanctity and Dignity of Human Life, which reads, in part: "At its core, abortion is a fundamental assault on the sanctity of innocent human life. Women deserve better than abortion."

If we are to change the political culture in our country to one that is pro-life, voters of all parties need to make this set of questions the primary concern in election decisions. We need to translate pro-life values into pro-life votes.
