Last year, our membership renewal letter began with remarks about potential changes following the Supreme Court’s 2022 Dobbs decision, noting: “since that decision merely sent abortion regulation back to each state, some states are liberalizing abortion-on-demand to a degree worse than the last 5 decades.” Heartbreakingly, that came to pass in Ohio, as we know all too well, after putting in a tremendous amount of time, effort, and money to fight the abortion giants’ Constitutional amendment in Ohio. Usually, we include a few notes about the past year in this letter, but please see our Jan/Feb 2024 newsletter for a year end summary. If you normally receive our newsletter by mail, that newsletter is enclosed with this letter, otherwise your newsletter has been sent by email as usual.

We are especially grateful for all Right to Life members this year for all that you did in prayer and work, and your generosity financially to try to stop the liberalization of abortion in Ohio. It is my hope that there will be yet-unseen fruits to those efforts; we spoke to a lot of people last year who are not normally in our sphere of influence, and we opened many eyes and hearts with our passion for every human person—mothers and fathers, children born and unborn, vulnerable adults being a light for our community. Shelby County, though not unanimously pro-family, compared favorably with other counties, ranking in the top 3 highest percentages of votes against the abortion amendment, and in the top 10 for voter turnout.

Please stop by our office thrift shop this year and thank our dedicated staff and volunteers who keep our downtown Sidney Thrift Shop operating, assisting many families with essential needs like diapers, clothing, food, and other financial and emotional support.
