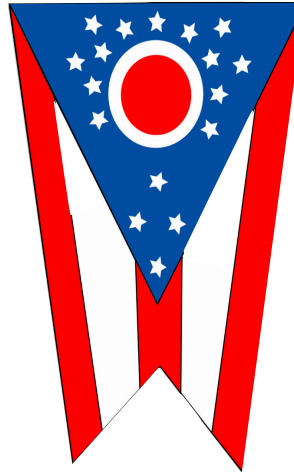


Moving On To The NOVEMBER BALLOT ISSUE

The disappointing August election results gave a win to the Ohio Communist Party, among other radical groups that tried to stop the common sense, long-overdue correction to our **constitutional** amendment process.

**But that election is behind us.
Now it's time to defeat November's
pro-abortion, anti-parent ballot measure.**

If you still have any of the **August election yards signs on your property or elsewhere, please remove them ASAP** to avoid confusion for the November election.



IMPORTANT ELECTION DATES

- Oct. 10—Voter registration deadline
For those turning 18; those recently moved; or any new voter.
- Oct. 11—Early voting begins
In-person or absentee by mail
- Oct. 31—Deadline for applications for absentee ballots
- Nov. 7—General Election Day.**
Polls open 6:30 a.m. to 7:30 p.m.

Why is the November Abortion Ballot Issue so Dangerous?

This radical proposal to change our *Constitution* (not just a regular law) would:

- ❖ **Remove safety regulations for abortionists**, including regulations for women's health.
- ❖ **Permit abortions through all 9 months of pregnancy**, for any reason, at the abortionist's own determination.
- ❖ **Enable abusers and human traffickers to force abortions** and continue their crimes. (The ballot petition says: "The State shall not...interfere" with anyone assisting "an individual" getting an abortion). Coerced abortion is common.
- ❖ **Remove parents from important reproductive medical decisions** involving their children, creating major safety issues, for vulnerable minors.
- ❖ **Force tax-payers to fund abortions and sex-changes** via tax funds.

Those pushing the abortion ballot measure on Ohioans will publicly deny these intentions, but documented evidence shows these are their goals. Legal analysts have also confirmed the ballot language would have the above effects on the law.

This is why we must inform people on voting **NO on November 7 or before.**



October 6: Join the STATE March for Life, in Ohio

New Kind of Serial Killer Targets Vulnerable People With Depression

Kenneth Law, 57, of Canada, is being investigated over a series of deaths by suicide linked to poisonous substances he sent to people around the world. Arrested in May, he has been charged in Canada on two counts of counseling or aiding suicide, and is being investigated in the UK, the USA, Italy, and New Zealand.

Mr. Law, a former chef, allegedly offered sodium nitrite, a lethal substance, and other methods of committing suicide on now-defunct websites. Over 1,200 packages are thought to have been ordered from these websites and delivered to people in 40 countries around the world. Mr. Law first came to the attention of authorities following an investigation by *The Times* newspaper in April 2023. It originally linked him to four deaths, but now that number has climbed to at least 21 possible victims, the youngest of whom was 17 years old when he died.

Many parents of the alleged victims have categorically condemned what they believe Law enabled their children to do. It was the death of 22-year-old Tom Parfett, after ingesting sodium nitrite, that sparked *The Times* investigation. His father David said, "You've got a man who's playing God with other people's lives, recklessly playing God." Parents of children who have accessed similar websites, not necessarily linked to Law, are watching his case with keen interest. Parents of his alleged victims are hoping it will set a precedent to help prevent pro-suicide forums and the sale of poisons online.

In 2021, the number of people who ended their lives by assisted suicide and euthanasia increased by over 32% from the previous year, accounting for 3.3% of all deaths in Canada.

DISCLOSURE STATEMENT. Protect Women Ohio, Inc. ("PWO") is an Ohio nonprofit corporation that is exempt from federal taxation under section 501(c)(4) of the Internal Revenue Code. PWO has voluntarily registered with the Ohio Secretary of State as a ballot issue political action committee. It may receive unlimited contributions from any source, including individuals, corporations, limited liability companies, trade associations, political organizations, and other legal entities, but does not accept contributions from foreign nationals, including individuals who are not citizens or lawful permanent residents of the United States as well as entities that are organized under the laws of a foreign country or whose principal place of business is in a foreign country. PWO is legally required to publicly disclose detailed information on all contributions, including the contributor's name and street address (as well as employer and occupation if aggregating \$100 or more). Contributions by one person in the name of another are prohibited. Contributions from individuals under the age of seven are prohibited. The IRS does not allow contributions to the Committee to be deducted as a charitable contribution for federal income tax purposes.
